Material Safety Data Sheet (MSDS)

Product and Company Identification

- **Product name:** Songbird Warming and Easing Balm
- **Uses:** This product is a warming rub.
- **Supplier:** Songbird Naturals Ltd (Co No: 5820629)

Information on Hazardous Ingredients

- This is a blend of natural ingredients and there are no known hazardous ingredients in the blend.
- Eye Contact – Medium hazard. Do not allow contact with the eyes or rub eyes with product on the hands. Wash hands thoroughly with warm water and soap after use. Irrigate with tepid/warm water, seek medical attention if necessary.
- Skin contact – It is a product for use on the skin and no known hazard is present. Use with caution on skin that is sensitive and in sensitive areas.
- Ingestion – data not available, but medical attention is advised as the product is a warming product.

Fire

- Hazard – Product is flammable. It has a high flash point. (+200c)
- Extinguishing method: Carbon Dioxide, foam or dry powder fire extinguisher. Do not use water jet.

Handling and Storage

- Good practice in hygiene is applicable for handling. Caution when handling the pot with the product on the hands as it is slippery.
- Product should ideally be stored at room temperature (18–21 degrees) or below. It will tolerate higher temperatures for short periods of time, but will become softer. If this is prolonged, or is much higher in temperature, the product may become more liquid than semi-solid. Performance may be impaired in this state.

Physical Properties

- **Visual Identification:** Product is a semi-solid blend of natural oils and waxes. It is pale yellow to orangey yellow in colour.
- **Touch Identification:** The product is waxy/oily and should spread easily on application to the skin.
- **Odour:** The characteristic odour of the Warming and Easing Balm is spicy and peppery.

Stability and Reactivity

- Heat promotes oxidation and should be avoided.
- Rancidity would be indicated by a rank/rancid odour. Under normal room temperature storage and usage conditions the product is generally stable and not prone to rancidity.

Ecological Information

- Non Toxic

Disposal Considerations.

- Tubs are polypropylene (PP) and are recycle category 5, which means that some facilities have the capacity for recycling. Dispose of according to local and national regulations.

- No restrictions on transportation by land, sea or air.
